- **COMMERCIAL INVOICE:** Must be issued in compliance with the LC or CAD in the name of the mentioned buyer, duly hand ***signed and stamped*** (mentioning under signature name and the title of person who signs).
- **PACKING LIST:** Must be issued in compliance with the LC or CAD in the name of the mentioned buyer, duly hand ***signed and stamped*** (mentioning under signature name and the title of person who signs).
- **Please check the Purchase Order:** the correct conditions, Incoterms, quantities, product, description, Customer consignee.
- **Fumigated Pallet Certificate** – ISPM 15 (The document is required, and each pallet must show a fumigation stamp).
- **Certificate of Origin** - Must be issued in compliance with the LC or CAD in the name of the mentioned buyer, duly hand ***signed and Stamped by the chamber of commerce.***
